ACQUISITION OF HYBRID AND NON-HYBRID SEEDS AND SEEDLINGS

- 1. In order to constitute a Directory of seed suppliers to be used for the first half of 2025, SoDeSeP SA. launches the present CALL FOR INTEREST for the selection of seed companies who will supply hybrid and non-hybrid seeds (maize, rice, soybean, cassava, potato, okra, tomato, pepper, onion, carrot...) and seedlings (papaya, mango, citrus, cashew...).
- 2. Companies with exclusive production/distribution rights for given varieties are particularly encouraged to submit their applications.
- 3. Participation is open to duly registered seed suppliers of all nationalities with recognized experience in the production/distribution of seeds and seedlings.
- 4. Interested candidates must not be affected by the provisions of Article 62 of Law No. 2020-26 of September 29, 2020 on the Public Procurement Code in the Republic of Benin and its implementing decrees.
- 5. Interested candidates are invited to express their interest by providing the following in their tender documents:
 - a letter of Expression of Interest dated, signed and sealed by the authorized person accompanied by a brief description of the company (maximum of two pages);
 - a portfolio or catalog of varieties/seed and seedlings, indicating their specific characteristics and any exclusive rights associated;
 - certificate of incorporation of the Company
 - proof of experience in seed production/distribution (at least one certificate of successful completion or equivalent documents);

- Evidence that the applicant has varieties well adapted to the West African tropical climate.
