







## INTERNATIONAL EXPRESSION OF INTEREST FOR THE CONSTITUTION OF A COMPLEMENTARY DIRECTORY OF SEED COMPANIES/SUPPLIERS FOR THE FIRST SEMESTER OF 2025

1. As part of the creation of a complementary directory of suppliers for the first semester of 2025, the Société béninoise de Développement des Semences et Plants (SoDeSeP SA.) is launching this call for expression of interest in order to extend his list of seed suppliers.

Below are the different seed types (hybrid or non-hybrid) and crops to consider:

- cereals: corn, rice, soya, sorghum, cassava, etc.;
- vegatable seeds: potatoes, okra, tomatoes, peppers, onions, carrots, etc.;
- seeds and nurseries: papaya, mango, citrus, cashew, etc
- 2. Suppliers that have exclusive rights for some varieties or seeds are particularly encouraged to submit those documents in their application.
- **3.** Participation is open to duly registered seed suppliers of all nationalities with recognized experience in the field of production/distribution of seeds and planting materials.
- **4.** Interested candidates should not be affected by the provisions of article 62 of Law No. 2020-26 of September 29, 2020 relating to the Public Procurement Code in the Republic of Benin and its implementing decrees.
- 5. Interested candidates are invited to express their interests by providing the following documents in their application:
  - a letter of Expression of Interest dated, signed and sealed by the authorized person accompanied by a brief presentation of the supplying company (maximum two pages);
  - a portfolio or catalog of varieties of seeds and plants with indication of their specificities and their possible exclusivity;
  - a summary table of varieties of seeds and plants with the specification "hybrid" or "non-hybrid" as appropriate;
  - the Certificate of incorporation;
  - proof of experience in seed marketing/distribution (at least one certificate of successful completion/delivery or equivalent);
  - proof that the candidate has varieties well adapted to the West African tropical climate (registration of varieties in the ECOWAS and/or CaBEV variety catalog).
